

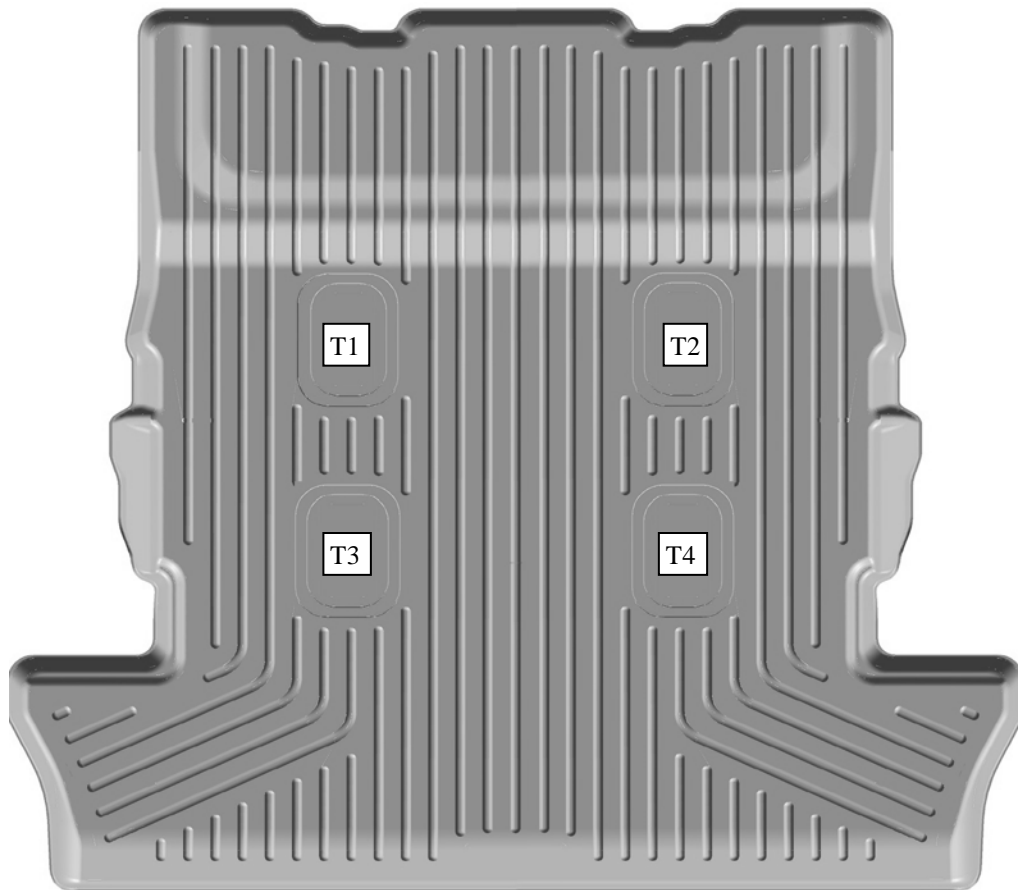
HUSKY **WeatherBEATER™** **Custom Vehicle Floor Protection**

CARE AND USE INSTRUCTIONS

Thank you for selecting a WeatherBeater™ Trunk Liner from Winfield Consumer Products. Your new cargo liner is custom molded to fit your Toyota Land Cruiser. Upon removal from the box your liner will not completely unroll and lay flat. This is normal and only temporary. Just place the liner on the floor or in the trunk of your vehicle with a weight in each corner (a book works well). After about 15 minutes, your liner will remain flat. In colder climates this “relaxing” may take longer; moving the liner to a heated area will accelerate the process.

Your liner is manufactured using an engineering resin that is lightweight and extremely tough and durable. The easiest way to clean your liner is with a damp cloth or sponge. If using a cleaner, 409® or Glass Plus® work well. Use of Armor All®, Son-of-a-Gun® or similar items is discouraged as these products make the liner slick.

CARGO LINER INSTALLATION INSTRUCTIONS FOR YOUR TOYOTA LAND CRUISER WITH THE STANDARD CARGO AREA



AS BOXED, YOUR CARGO LINER GIVES FULL CARPET PROTECTION. IT IS DESIGNED TO ALLOW USE OF THE 3RD ROW SEATS SHOULD YOU WISH TO EMPLOY THEM. THERE ARE FOUR (4) TRIM AREAS THAT MUST FIRST BE REMOVED TO ALLOW THE 3RD SEATS TO FOLD AND ATTACH TO THE CARGO FLOOR. THESE AREAS ARE DENOTED AS T1, T2 T3 AND T4 ABOVE. TO TRIM, USE THE INSIDE EDGE OF THE BAND SURROUNDING THE TRIM AREA AS YOUR GUIDE (SEE PHOTO ON BACK). A UTILITY KNIFE WORKS WELL FOR TRIMMING THESE AREAS.

Return alleged defective part to the place of purchase for replacement. Please have a copy of your purchase receipt available when you call. The foregoing is the only express warranty made by the manufacturer and is limited to the duration of this warranty. **ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS LIMITED IN DURATION TO THE DURATION OF THIS WARRANTY. LABOR CHARGES, INJURIES, OR ANY OTHER LOSS OR DAMAGES WHATSOEVER, INCLUDING THOSE INCURRED IN INSTALLATION ARE EXCLUDED. ADDITIONALLY, PAINTING OF REPLACEMENT HUSKY LINER PARTS AND ANY VEHICLE COMPONENT REPAIR OR REPLACEMENT AS WELL AS INCIDENTAL DAMAGES ARE EXCLUDED.**

This warranty is void for damages to the product due to misuse, abuse, neglect, accident, improper installation or any use that violates the instructions furnished by us.

ABNORMAL WEAR AND TEAR ARE NOT COVERED UNDER THIS WARRANTY. Obviously, if your dog chews up your Husky Liner product, it's not covered under the warranty. Likewise, if you shut your Husky Liner in the door of your vehicle, damage to the liner and/or door are not covered. Commonplace, everyday wear on a particular product is considered normal, and is not covered under warranty repair.
